Action Items:

Discussion Highlights:

1. Agenda Review and Updates

- The September Subcommittee meeting has been rescheduled to 9/17, 1pm-4pm
- The Delta Science Program is hosting a Spring-Run Workshop from September 8 10

2. Coordinated Salmonid Science Plan

- Remaining content to finalize:
 - Case studies (later agenda item)
 - o Complete cross-walk with parallel plans (SRSP SP, CVPIA)
 - o Finish "Next Steps" section of the plan
- Final report parameters:
 - Targeting 20 –25 pages.
 - Audience is primarily management-oriented, but valuable for scientists too (focus is on science serving management).
 - No-frills approach due to budget considerations.
- Results will be presented as a "Thematic Exploration by Agreement"
 - o Theme 1 Beneficial Activities with the Most Agreement on Benefits
 - o Theme 2 Activities with High Agreement, Low Barriers to Implementation
 - o Theme 3 Key Activities With Low Agreement
- Alignment with other plans
 - Exploratory conversations are ongoing with leads of the SRSP Science Plan, CVPIA Near-Term
 Strategies, and Delta Smelt SDM Process
 - o The CSSP will:
 - Summarize overlapping activities / themes with high-level crosswalk table
 - Discuss broader benefits of alignment (overlap, complementarity, portfolios, data standardization / interoperability)
 - Refer to 'next steps' section for suggestions on continuing collaboration
- Next Steps
 - September 7: ESSA shares draft CSSP for Subcommittee's review
 - September 15 CAMT meeting: ESSA presents high-level overview of draft plan
 - o September 17 Subcommittee meeting: Subcommittee discussion regarding draft plan
 - September 25 Subcommittee comments due
 - Week of October 5: ESSA delivers final CSSP
- Subcommittee feedback on next phase of salmon planning
 - o The next phase should focus on quantifying benefits and prioritizing which actions to model
 - Consider prioritizing actions based on most at-risk species
 - o Focus on CSAMP's work plan and its geographic scope, e.g. what is in Delta should be a priority
 - Make recommendations regarding science to pursue in the near-term (also a focal point of the SRSP)
 - o Digest draft plan before diving into more concrete discussions regarding next steps

2. Salmon Entrainment Proposal

- Modifications were made to study proposal based on comments received at Subcommittee, CAMT and follow-up conference call
- This effort is currently on hold while additional discussions take place (between PWAs, DWR, CDFW)
 regarding alignment with ITP requirements

3. Future Subcommittee Topics/Presentations Discussion

- Consider having CDFW/DWR share their concerns regarding ICF's Entrainment Loss Model and present on their own parallel effort before presenting to CAMT/CSAMP in December.
 - o Carl present on CDFW/DWR's concerns at September Subcommittee meeting
 - Synthesis paper on work done by DWR, Cal Trout, UC Davis in the Yolo Bypass (rice field work, lessons learned, recs for moving forward), Ted Sommer would be presenter.
 - Paper should be out in Estuary Journal in September. Ted could do a preview during August
 CAMT meeting. If CAMT approves, include presentation on paper in CSAMP agenda
 - Consider Anchor QEA's approach to work funded by DSP for October Subcommittee meeting
 - Pascale follow up with Dylan re: DSP projects that can be presented at future meetings
 - Bruce/Rafi to ask ESSA about timing of CSSP presentations
 - o CAMT in September?
 - o CSAMP in December?

4. Subcommittee meetings plus/delta
